




How to Become the RSSDI Member


Please follow below steps to apply for RSSDI Membership and become a Member

STEP 1 : Go to RSSDI Official Website through the underlying URL :
www.rssdi.in


STEP 2 : EITHER Take the cursor to Membership head and click “Become a Member” from the dropdown



OR Take the cursor to Pay Online head and click “Registration for Membership” from the dropdown



STEP 3 : Below like screen will open.



STEP 4 : Fill the details asked in the form like personal details, First PG Degree Year, Qualification, Street, Town, State, Pin Code, Work Phone, Home Phone, Fax, PAN Card Number and upload documents like Photo (For iCard & personalized certificate), Degree (MBBS/MD/DM/MSc/PhD) Certificates, PAN Card Scanned copy and Copy of Registration with the Medical Council.

Note : All the requested documents are mandatory to upload.

Note : To upload the document, click “Choose File” option and select the document to upload.



STEP 6.2 (if you are paying the membership fee through Offline method) : Once you click Submit button. You will see a confirmation message on the screen that you have successfully submitted the form on RSSDI website. Send the DD or cheque via post to RSSDI, Secretariat address i.e.
